NOTICE OF RACE

Frühlings-Regatta for the MicroCupper and Open5-Class
Landesmeisterschaft NRW MicroCupper,
Rangliste Euro Micro, Rangliste „Tour durch Deutschland“

from 30 April 2022 to 01 May 2022

Including all amendments until April 18th in the German version

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

1. RULES

- 1.1 The event is governed by the rules as defined in The Racing Rules of Sailing (RRS).
- 1.2 The prescription of the German Sailing Federation (DSV) also applies which can be downloaded from the homepage of the DSV: www.dsv.org: >>Service >>Mitgliederservice >> Downloads.
- 1.3 [DP] RRS 40.1 applies at all times while afloat.
- 1.4 If there is a conflict between languages the English text takes precedence. For the national prescriptions of the German Sailing Federation (DSV), the Notice of Race and the Sailing Instructions the German text takes precedence.
- 1.5 The infection and hygiene regulations of the corona protection ordinance of the state of NRW, the city of Zülpich and the club RSCZ in the version valid at the time of the event. They will be displayed at the clubhouse as well as at the race office.

2. SAILING INSTRUCTIONS

The Sailing Instructions will be available at registration. Further they will be available on the event website from 2022, April 23rd on.

3. COMMUNICATION

- 3.1 The official notice board is located at a window of the clubhouse.
- 3.2 [DP] While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

4. [NP] [DP] ELIGIBILITY AND ENTRY

- 4.1 The event is open to all boats of the class(es) as follows:
Micro classes (Proto, Racer, Cruiser) and Open5 (Small cabin boats up to 6m length)
- 4.2 The skipper shall provide a valid official licence prescribed or recommended for the racing area and type of drive. This may be either an official licence or an equivalent DSV licence, "Sportsegelschein" or for the relevant age group a "Jüngstensegelschein". Members of other national authorities shall provide an equivalent licence issued by their national authority.
- 4.3 Each competitor shall be a member of a club affiliated to his national authority of World Sailing.

- 4.4 Eligible boats may enter the event by registering online at the event website.
- 4.5 To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees until 2022, April 21st.
- 4.6 If there are less than 10 boats enrolled in a class up to 2022, April 22nd, the organizer will decide whether the race for the class will take place or not.

5. FEES

- 5.1 Entry fees are as follows:

	Early Entry fee (EUR) until 21 April 2022	Entry fee (EUR) from 22 April 2022 to 2h before the first race
Boats of Three	60,00€ / boat	70,00 € / boat
Boats of Two	20,00 € / boat	50,00 € / boat

- 5.2 The entry fees include dinner as well as drinks on Saturday evening.
- 5.3 Other fees: Not
- 5.4 The entry fee shall be paid upon entering, even if the entry is cancelled later or the boat does not show up. The entry fee is non-refundable, except for the event or class being canceled by the organizing authority or if the entry is rejected.
- 5.5 The entry fee shall be paid to the bank account of "Ruder- und Segelclub Zülpich e.V." at KSK Euskirchen, BIC: WELADED1EUS, IBAN: DE14 3825 0110 0001 2142 04 naming the event, the name of the helmsman and the sail number.

6. [DP] ADVERTISING

- 6.1 Boats may be required to display advertising and bow numbers chosen and supplied by the organizing authority.

7. SCHEDULE

- 7.1 Registration:

- 7.2 On the first scheduled racing day a skippers meeting will be held at 12:00 hrs. Details will be posted in the Sailing Instructions.
- 7.3 The schedule of races and dates of racing is as follows:

- 7.4 On the last scheduled day of racing, no warning signal will be made after 14:00 hrs.
- 7.5 On 29 April 2022 the club area will be opened at 17:00h and a support for launching boats will be provided.

8. EQUIPMENT INSPECTION

- 8.1 Each boat shall produce or verify the existence of a valid measurement or rating certificate.
- 8.2 Boats may be inspected at any time.

9. VENUE

- 9.1 The event will be hosted at the “Wassersportsee Zülpich”. The travel information is available at <https://segelclub-zuelpich.de/kontakt/>.
- 9.2 The race office will be located at club house.
- 9.3 The racing area will be the “Wassersportsee Zülpich”.

10. COURSES

The courses will be defined in the Sailing Instructions.

11. PENALTY SYSTEM

- 12.1 For all classes the RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

12. SCORING

- 12.1 One race is required to be completed to constitute a series.
- 12.2 Three races are required to be completed as well as 3 boats are required to be registered from NRW to constitute the “Landesmeisterschaft NRW Micro Cupper”.
- 12.3
 - a) When fewer than [4] four races have been completed, a boat’s series score will be the total of her race scores.
 - b) When [4] four or more races have been completed, a boat’s series score will be the total of her race scores excluding her worst score.

13. [NP] [DP] SUPPORT PERSON VESSELS

- 13.1 Support person vessels are not permitted.

14. [DP] BERTHING

Boats shall be kept in their assigned places while in the boat park or berth.

15. [DP] MEDIA RIGHTS

- 15.1 Upon registration to the event competitors agree that photos and videos may be taken of their person and used as part the organizing authority’s public relations activities, e.g., via websites, newsletters, print and tv media and social networks. In addition, competitors or their guardians grant to the organizing authority without compensation the unlimited right to use images, photographs, television and radio material produced of them during the event.
- 15.2 The organizing authority could post data of the competitors (name, club, place) by announcements, raceoffice.org as well as on its web site. The organization authority reserves the right to disclose of above mentioned data to press, print or electronic media.
- 15.3 Competitors may be required to be available for interviews at the event.

16. DATA PROTECTION

The organizing authority will process and store personal data collected from entering and participating in the event. Addendum “Data Privacy Policy” gives relevant information and details. 17. LIMITATION OF LIABILITY COGNOVITS CLAUSE

- 17.1 The responsibility for the decision to participate in a race or to continue with it is solely with the skipper; to that extent the skipper also accepts full responsibility for the crew. The skipper is responsible for the qualification and the correct nautical conduct of the crew as well as for the suitability and the seaworthiness of the registered boat. In cases of force majeure or on grounds of administrative orders or for safety reasons, the organizer is entitled to make changes in the realization of the event or to cancel the event. This does not constitute any liability by the organizer towards the participant, if the reasons for the changes or the cancellation do not result from a willful or grossly negligent behaviour of the organizer. In case of a violation of obligations that do not constitute main / essential contractual duties (primary obligations), the liability of the organizer for financial and property damages incurred by the participant during or in connection with the participation in the event and resulting from a conduct of the organizer, its representatives, servants or agents, is restricted to damages that were caused willfully or grossly negligent. When a violation of primary obligations occurs due to minor negligence, the liability of the organizer is limited to foreseeable, typical damages. To the extent that the liability for damages of the organizer is excluded or restricted, the participant also relieves the staff - employees and representatives, agents, servants, sponsors and individuals who provide or drive salvage, safety or rescue vessels or assist with their use - from the individual liability for damages, as well as all other individuals who were instructed to act in connection with the realization of the event.
- 17.2 World Sailing's effective Racing Rules of Sailing (RRS), the constitution and regulations of German Sailing Association (DSV), especially its regulations on regattasailing (Ordnungsvorschriften Regattasegeln), the class rules as well as the regulations of the Notice of Race and the Sailing Instructions are to be complied with and are expressly recognized.
- 17.3 German law applies.
- 17.4 Competitors shall present a signed and completed consent and declaration form at registration. For competitors under 18 years of age these forms shall be signed by a parent or guardian. The forms can be downloaded from the event website.

18. [DP] INSURANCE

Each participating boat shall be insured with valid (and for the racing area suitable) third-party liability insurance with a minimum cover of 3.000.000 EUR per incident or the equivalent.

19. PRIZES

- 19.1 Prizes will be awarded to the top three overall scored boats. Further prizes to the first places of each category (Proto, Racer, Cruiser und Open 5). For the "Landesmeisterschaft NRW" certificates will be awarded.
- 19.2 Prizes not claimed at the prize giving ceremony will remain with the organizing authority.
- 19.3 The „Landesmeister NRW“ is/are entitled to participate at the next following „SVNRW Meisterschaft der Landesmeister“.
